This agreement is made by and between Stacey Tucker., (“Stallion Manager”) of Principle Decision, AQHA Stallion (the “Stallion”), and

_____, the owner (the “Mare Owner”) of the following Mare (the “Mare”):

The Stallion Manager and the Mare owner (collectively, the “Owners”) hereby agree as follows:

1. The Mare Owner agrees to breed the above named Mare to the above named Stallion standing at SR Tucker Quarter Horses, Scottsdale, Arizona and pay a breeding service fee of \$500.00; in addition, a fee of \$350 as a (Non Refundable) booking/ collection/chute fee. The mare will not be bred unless the booking/collection/chute fee has been paid. The Booking/Collection fee will be payable to Stacey Tucker, breeding farm manager/reproduction technician for SR Tucker Quarter Horses and the service fee is payable to SR Tucker Quarter Horses, LLC.
2. The \$350.00 Booking /Collection fee will be for the first breeding cycle (as many collections it takes). If the mare has to be bred back on the next heat cycle, a \$350.00

collection fee will be billed to the Mare Owner. The chute fee is for the veterinarian's and reproduction technician's services, materials, supplies, and labor costs. For what ever reason, some mares may not become pregnant on the first heat cycle, therefore, the mare will have to be bred back and a chute fee must be applied for each breeding cycle. Please have your mare ready for breeding by; (1) having the mare checked by a veterinarian, (2) provide a good nutrition program, (3) regular deworming (4) current vaccinations, (5) and have the mare cultured. Please address any past or present problems to SR Tucker Quarter Horses. Thank You

3. ALL FEES NONREFUNDABLE
4. Please check and/ or complete, as appropriate:

5. The Mare may be checked to verify normal breeding condition and the Stallion Manager who for purposes of this agreement may render any treatment or immunization that they determine is reasonably necessary. The cost of any such services will be borne by the Mare Owner and added to the service fee.
6. If Mare Owner at any time fails to satisfy one or more of the provisions set fourth in this agreement, Stallion Managers will have no further obligation hereunder and will not be required to breed the mare. If the Stallion dies; is sold or otherwise disposed of; ceases to be breeding sound; or otherwise becomes unavailable for breeding before the Mare produces a live foal (as hereafter defined), the Stallion Managers sole obligation under this agreement will be to return any previous paid breeding fee to the Mare Owner.
7. The Stallion Managers will exercise their best judgment in caring for and supervising the Mare and its foal and neither the Stallion Managers, its agents, employees, or representatives will be responsible for accident, sickness, death or other injury to the Mare and its foal. Mare Owner will similarly not be responsible for any accident or injuries to horses belonging to the Stallion Managers, or in their care and possession, caused by the Mare or its foal.
8. **A copy of the Mare's registration papers must be returned with this agreement.**
9. If the breeding contemplated by this agreement fails to produce a live foal, the Stallion Managers will, after the payment of the Booking Fee for the 2011 breeding season, rebreed the Mare in such season. For the purposes of this agreement a "live foal" is one that stands and nurses after foaling. The obligation to rebreed will apply only if the Mare Owner notifies the Stallion Managers in writing within 48 hours from the death of the foal. The notice required by this paragraph must be accompanied by a statement from a duly licensed veterinarian verifying such facts. The Stallion Managers' obligation to rebreed shall become null and void if, after the breeding contemplated by this agreement, the Mare is returned to training. If the Mare dies without producing a live foal before the end of the 2011 season, the Mare Owner may upon payment of the Booking/Chute fee,

substitute another mare belonging to the Mare Owner in place of the mare during the 2011 season and such mare shall be considered the Mare for purposes of this agreement.

The Mare Owner will pay SR Tucker Quarter Horses for board. Furthermore, the Mare Owner will pay all boarding / veterinary/ farrier/ and care fees monthly, and agrees to pay any balance owing before the Mare is picked up.

10. Should Mare Owner fail to deliver the Mare on or before _____ to SR Tucker Quarter Horses for the purpose of breeding, the Stallion Managers shall have no further obligations under this agreement.
12. This agreement may not be assigned by the Mare Owner without the prior written consent Of the Stallion Managers.
13. The Mare shall be delivered for breeding with a negative coggins test within 180 days prior to such delivery (applies to out of state horses) and a negative culture with the Mare is in season.

Addendum for Transported Semen

1. I, _____ do hereby request shipped semen for the above named Mare. I understand that in addition to the breeding, booking fees, I will be responsible for all costs an arrangements (withy my veterinarian and SR Tucker Quarter Horses) of the shipping process.
2. I agree to the following fees:
 - a. the nonrefundable booking/chute (collection) fee of \$350.00 made payable to SR Tucker Quarter Horses, LLC. Included in the collection fee is the shipping container fee. Plus, the Stallion breeding fee made payable to SR Tucker Quarter Horses, LLC. If the Mare has to be bred back on the next heat cycle a \$350.00 collection (collection fee will be billed to the Mare Owner.
 - b. Mare Owner agrees to be responsible for all shipping expenses related to the ordering of shipped semen. We recommend you contact Federal Express to set up a billing account (1-800-463-3339). SR Tucker Quarter Horses has established an account for all shipment pick-ups. Pease refer to account number 249530077. All shipping arrangements must be made between SR Tucker Quarter Horses, the Mare Owner, and the shipping company for pickup and deliver times, and directions. After receipt and use of semen, the container must be shipped back to SR Tucker Quarter Horses using over night delivery. There will be a late container fee of \$25.00 per day for every day the container is gone past 2 days.
ALL FEES AND COSTS MUST BE PAID BEFORE SEMEN WILL BE SHIPPED
3. Reservations for shipped semen:

- a. Fresh Cooled Semen will be collected on breeding days.
Monday/Wednesday/Friday
- b. All Semen orders must be received by 12:00pm the day before the requested collection date. Please call: (520)405-9609. If no answer, please leave a message and your order will be confirmed that evening. Late orders are not guaranteed.
- c. Semen orders will be filled in this order of priority:
 1. All mares on premises of SR Tucker Quarter
Horses will be served first.
 2. If there is sufficient semen to fill all orders of a given day, the breeding farm manager, will determine which orders will be honored. This decision will be based on the information provided by the Mare Owner's veterinarian.
 3. SR Tucker Quarter Horses requires that you notify the breeding farm manager when the mare first exhibits signs of heat.
 4. SR Tucker Quarter Horses also requires notification by the Mare Owner's veterinarian to the breeding farm manager the day before the desired collection.

Conditions:

- a. Semen shall only be provided to healthy mares in sound breeding condition as Determined by a veterinarian.
- b. In all cases, the veterinarian must certify that the mare's equine rhinopneumonitis has been kept current.
- c. All mares are required to be examined by veterinarian by rectal and ultrasound.
- d. Mare Owner agrees to have the Mare examined for pregnancy by ultrasound and submit the results along with insemination and conception reports to SR Tucker Quarter Horses within 16 days after ovulation of that cycle. It is recommended to have the Mare checked by ultrasound at 28 days, 45, days, and then 60 days for pregnancy conformation. In the event the mare is barren, SR Tucker Quarter Horses requires the submission of a negative culture.
- e. Mare Owner agrees that cooled semen requires special handling and that attempts to breed mare outside controlled conditions of an equine breeding farm, reproduction center, or veterinary facility, can greatly reduce, and some cases prevent chances of conception.

Return of Service:

1. The purchaser is entitled 2 semen shipments per estrous cycle.
2. This contract contains a live foal guarantee.

Liability:

- a. The Stallion Manager of SR Tucker Quarter Horses is not responsible for lost, delayed, damaged semen, and makes no representation or warranties of any kind with respect to semen except that it is from booked Stallion, Principle Decision, and also, that choice of shipper is at the Mare Owners discretion. Mare Owners bears risk of loss.
